INDICATIONS

This product is designed specifically for dairy cows and is formulated to include the following mineral levels:

DOSE RATES

Administer DairyMin® 8 at 15ml per cow per day, from approximately one month prior to calving through to the end of mating. The 15ml dose rate is suitable for animals 500kg and over and should be reduced by 2ml per 100kg for smaller animals. Depending on individual herd nutritional requirements, DairyMin® 8 may be continued post mating through lactation. DairyMin 8® comes in a ready-to-use liquid form. SHAKE or STIR well before administering through a calibrated water system.

FOR DAIRY COW USE ONLY. DO NOT ALLOW SHEEP OR GOATS TO INGEST THIS PRODUCT. DO NOT EXCEED THE STATED DOSE AND FREQUENCY EXCEPT UNDER ADVICE FROM VETERINARIAN OR NUTRITIONAL ADVISOR.

CAUTION

DairyMin® 8 is a high mineral content product. The following cautions are advised:

- Do not give this product to cows with liver damage.
- Do not use where the domestic house water supply is directly connected to the farm water trough system.
- Do not use at the same time as other supplements or fertilisers which contain Copper or Selenium, without the advice of a veterinarian.

HANDLING

Keep out of reach of children. Do not handle until all safety precautions have been read and understood. Avoid breathing mist/vapours/spray. Contaminated work clothing should not be allowed out of the workplace. Wear protective gloves/protective clothing/eye protection/face protection. Wash hands thoroughly after handling. Do not eat, drink or smoke when using this product. Use only outdoors or in a well-ventilated area. Avoid release to the environment. Collect spillage.

FIRST AID
