EMERGENCY PROCEDURES

24 HOUR ADVICE IN AN EMERGENCY ONLY: 0800 764 766

IF THIS HAPPENS	DO THIS
Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away and warn other traffic. Check for spills and leaks. Call the emergency services: Dial 111. If major spill occurs, evacuate all personnel upwind.
Spill or Leak	Major spills: Call the Fire Department and alert them to the nature of the spill. Clear area of all personnel and move upwind. For minor spills, remove all ignition sources, and prevent further spillage. By any means prevent spill from entering waterways. Wearing personal protective equipment and breathing apparatus, absorb spill with inert material, and sweep up into a sealable container.
Fire	Immediately call the Fire Department: Dial 111. Wear protective equipment and breathing apparatus. Extinguish with water spray (fog), foam or dry chemical powder. Do not use a water jet. Toxic fumes may be emitted.

FIRST AID

If Swallowed:	Harmful if swallowed. Do NOT induce vomiting. Rinse mouth. If unwell call a POISON CENTRE (0800 764 766) or doctor/physician. If medical advice is needed, have product container or label at hand.
If in Eyes:	Wash eyes cautiously for 15 minutes. Remove contact lenses if they are present and it is easy to do so. Continue rinsing. If irritation persists, call a Poison Centre or doctor/physician
If on Skin:	Quickly remove all contaminated clothing and footwear. Immediately flush body with large amounts of soap and water, or use a safety shower if available.
If Inhaled:	Remove to fresh air and keep at rest in a position comfortable for breathing. If ill effects persist, contact doctor or poison centre for advice.

STORAGE AND SEGREGATION SUMMARY

Storage: Keep out of reach of children. Store locked up in original container with lid tightly closed in a cool, dry, well-ventilated area out of direct sunlight. Store away from incompatible materials, food and seeds. Avoid physical damage to container and check regularly for leaks.
