DANGER

READ LABEL BEFORE USE

Do not breathe fume/mist/vapours/spray.
Wash contaminated skin thoroughly after handling.
Avoid release to the environment.
Wear protective gloves/protective clothing/eye protection/face protection.
Collect spillage.

DIRECTIONS FOR USE

General dairy shed cleaning, floors, walls and pipe-work add one litre of HYPO to three litres of water.
To boost sanitizing of Alkali cleaners (CIRCIMATE) add one litre of HYPO for every 1kg Alkali used.
Food surfaces must be thoroughly rinsed with potable water before production starts.

STORAGE

Keep only in original container, tightly closed, away from foodstuffs. If required store in corrosive resistant container with a resistant inner liner. Keep out of direct sunlight. Store locked up in a cool place.

DISPOSAL

Preferably dispose of product by use. Otherwise dispose of product, packaging and waste at an approved landfill or equivalent facility in accordance with local, regional and national environmental regulations. FIRST AID

If medical advice is needed, have product container or label at hand.

IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Call a POISON CENTRE or doctor/physician if you feel unwell.

IF ON SKIN (or hair): Take off immediately all contaminated clothing. Rinse skin with water/shower. Wash contaminated clothing before reuse.

IF INHALED: Remove to fresh air and keep at rest in a position comfortable for breathing. Immediately call a POISON CENTRE or doctor/physician.

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.
