| IF THIS HAPPENS | DO THIS |
|--------------------------------|--|
| Tanker/Vehicle Accident | Switch off engine and electrical equipment. Keep people away and warn other traffic. Check for spills and leaks. Call the emergency services: Dial 111 |
| Spill or Leak | Major spills: Call the Fire Department and alert them to the nature of the spill. In the event of a major spill, prevent spillage from entering drains or water courses. Wear full protective clothing including eye/face protection. Stop leak if safe to do so, and contain spill. Absorb onto sand, vermiculite or other suitable absorbent material. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. |
| Fire | Call the Fire Department: Dial 111. Wear full protective clothing and self-contained breathing apparatus. Use extinguishing media suited to the surrounding fire. Do not allow firefighting water to escape into waterways or sewers. |

| If Swallowed: | Call a poison control centre or doctor for treatment advice. |
| If in Eyes: | If in eyes, rinse cautiously with water for several minutes. Remove contact lenses, if present, and easy to do so. Continue rinsing. If eye irritation persists: Get medical advice/attention. |
| If on Skin: | Take off contaminated clothing. Rinse skin immediately with plenty of water. If skin irritation occurs: Get medical advice/attention. |
| If Inhaled: | If inhaled, move victim to fresh air immediately. Begin artificial respiration if breathing has stopped and get immediate medical assistance. |

STORAGE AND SEGREGATION SUMMARY

Storage: Store in original container tightly closed and in a locked dry cool area away from foodstuffs, seeds and fertilizers. Store in accordance with NZS 8409 Management of Agrichemicals.
