Keep people away and warn other traffic. Check for spills and leaks. Call the Accident emergency services: Dial 111. If major spill occurs, evacuate all personnel upwind. Major spills: Call the Fire Department and alert them to the nature of the spill. Clear area of all personnel and move Spill or Leak upwind. For minor spills, remove all ignition sources, and prevent further spillage. By any means prevent spill from entering waterways. Wearing personal protective equipment and breathing apparatus, absorb spill with inert material, and sweep up into a sealable container. Immediately call the Fire Department: Dial 111. Liquid and vapour are highly flammable. If large quantities are Fire affected by fire, consider evacuating to 500m in all directions. May be violently or explosively reactive. Wear chemical protective equipment and breathing apparatus. Extinguish with foam or dry chemical powder. **FIRST AID** If Swallowed: Harmful if swallowed. Do NOT induce vomiting. Rinse mouth. If unwell call a POISON CENTRE (0800 764 766) or doctor/physician. If medical advice is needed, have product container or label at hand. If in Eyes: Wash eyes cautiously for 15 minutes.
