**EMERGENCY PROCEDURES**

**24 HOUR ADVICE IN AN EMERGENCY ONLY: 0800 764 766**

IF THIS HAPPENS	DO THIS
<b>Tanker/Vehicle Accident</b>	Switch off engine and electrical equipment. Keep people away and warn other traffic. Check for spills and leaks. <b>Call the emergency services: Dial 111</b>
<b>Spill or Leak</b>	<b>Major spills: Call the Fire Department and alert them to the nature of the spill.</b> Evacuate personnel to safe areas. Avoid breathing vapours/mist. Use appropriate tools to put spill material in a suitable chemical waste container. Clean contaminated surface thoroughly. Ensure adequate ventilation. Wear protective gloves and face/eye protection and protective clothing. Prevent washings from entering waterways. Do NOT flush into surface water or sanitary sewer system.
<b>Fire</b>	<b>Call the Fire Department: Dial 111.</b> Wear protective gloves and clothing and self-contained breathing apparatus. Extinguish fires with water spray, alcohol resistant foam, dry chemical powder or carbon dioxide. Contain and collect run-off (see <b>Spill or Leak</b> section above). Fire may cause evolution of carbon oxides, nitrogen oxides (NOx) and sulphur oxides.

**FIRST AID**

<b>If Swallowed:</b>	Immediately call the POISON CENTRE or contact a doctor/physician if you feel unwell. Do NOT induce vomiting.
<b>If in Eyes:</b>	Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do so. Continue rinsing. Get medical advice/attention.
<b>If on Skin:</b>	Wash with plenty of soap and water. If skin irritation or rash occurs: Get medical advice/attention. Wash contaminated clothing before use.
<b>If Inhaled:</b>	Remove to fresh air and keep at rest in a position comfortable for breathing. If experiencing respiratory symptoms, call the POISON CENTRE or doctor/physician.

**STORAGE AND SEGREGATION SUMMARY**

**Storage:** Keep out of reach of children. Store locked up below 25°C out of direct sunlight. Keep container tightly closed and in a dry and well-ventilated area.
