DANGER

READ LABEL BEFORE USE

Wear protective gear including gloves, protective clothing, and eye protection. Wash hands thoroughly after handling. Do not eat, drink or smoke when using this product. Do not breathe vapour or spray. This material may be harmful if swallowed. Avoid direct contact of the concentrate on skin or eyes. Rinse with cold water for first aid. For Animal Treatment Only.

DIRECTIONS FOR USE

Mix one part UDDERCONTROL teat sanitiser with four parts clean water. After milking thoroughly spray the udder area to ensure all over cover of cows teats.

In extreme muddy or dry conditions up to 5% of water can be replaced by additional emollient.

It is recommended to spray cows teats after each milking throughout the dairy season to assist in the control of mastitis.

By law the user must take due care, obtaining expert advice when necessary, to avoid unnecessary pain and distress when using the product other than as directed on the label.

STORAGE

Keep only in original container, tightly closed, away from foodstuffs. Keep out of direct sunlight. Store locked up in a cool place

FIRST AID

If medical advice is needed, have product container or label at hand.

IF SWALLOWED

Do NOT induce vomiting. Rinse mouth and then drink plenty of water.

Call a POISON CENTRE or doctor/physician if you feel unwell.

IF ON SKIN:

Wash with plenty of soap and water

Rinse cautiously with water for several minutes.
Remove contact lenses, if present and easy to do.
