**EMERGENCY PROCEDURES**

**24 HOUR ADVICE IN AN EMERGENCY ONLY: 0800 764 766**

IF THIS HAPPENS	DO THIS
<b>Tanker/Vehicle Accident</b>	Switch off engine and electrical equipment. Keep people away and warn other traffic. Check for spills and leaks. <b>Call the emergency services: Dial 111. If major spill occurs, evacuate all personnel upwind.</b>
<b>Spill or Leak</b>	Wear PVC overalls, chemical resistant gloves, face mask or goggles. Prevent further spillage. Absorb spilled product and place on a sealable container for disposal. Wash down affected area with water and detergent. Absorb and collect washings and place in same sealable container for disposal. Seek advice from local authority regarding disposal.
<b>Fire</b>	<b>Immediately call the Fire Department: Dial 111.</b> Wear PVC protective clothing and breathing apparatus. Extinguish fires with foam, dry chemical and carbon dioxide. During a fire toxic fumes may be released. Cool sealed drums with cold water to prevent rupture due to thermal expansion. Contain run-off. Keep non-involved persons away.

**FIRST AID**

<b>If Swallowed:</b>	Harmful if swallowed. Do NOT induce vomiting. Immediately call a POISON CENTER or doctor/physician. If medical advice is needed, have product container or label at hand.
<b>If in Eyes:</b>	Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.
<b>If on Skin:</b>	Wash with plenty of soap and water. Do not scrub skin. If skin irritation or rash occurs: Get medical advice/attention. Wash contaminated clothing before reuse.
<b>If Inhaled:</b>	Remove to fresh air and keep at rest in a position comfortable for breathing. If ill effects persist, contact doctor or poison centre for advice.

**STORAGE AND SEGREGATION SUMMARY**

**Storage:** Store in original container in a cool, dry, ventilated place away from direct heat or sunlight. Store away from foodstuffs, animal feeds, children and animals. Keep container sealed when not in use.
